9 I, Paul Ferruzzi declare as follows:

10 **INTRODUCTION**

11 1. I am a Senior Manager of Kroll Settlement Administration LLC  
12 (“Kroll”), the settlement administrator retained by Settlement Class Counsel<sup>1</sup> in  
13 the above-captioned case to provide administration services and notice as  
14 approved by the Court in connection with the settlement agreement entered into  
15 in connection with this matter (the “Settlement Agreement”). Our principal office  
16 is located at 2000 Market Street, Suite 2700, Philadelphia, Pennsylvania 19103.

17 I am over 21 years of age and am authorized to make this declaration on behalf of

1 Kroll and myself. The following statements are based on my personal knowledge  
2 and information provided by other experienced Kroll employees working under  
3 my general supervision.

4       2. This supplemental declaration is being made to update the Court  
5 regarding timely requests for exclusion received in connection with this matter,  
6 and further supplements the declaration filed on May 23, 2022, “Supplemental  
7 Declaration of Jeanne C. Finegan, APR Concerning Settlement Administration  
8 and Class Member Notification In Support of Final Approval” (the “Prior  
9 Supplemental Declaration”).

10       3. As noted in the Prior Supplemental Declaration, the Opt-Out  
11 Deadline was May 13, 2022. As of May 23, 2022, the date of the filing of the  
12 Prior Supplemental Declaration, Kroll had not received any requests for  
13 exclusions or objections to the Settlement.


14       4. Kroll regularly audits its mail and correspondence. During one of  
15 these audits, on June 23, 2022, Kroll identified eight (8) exclusions that had been  
16 scanned on or about June 7, 2022, but not identified as exclusions. While these  
17 exclusions were received weeks after the deadline, Kroll can confirm their  
18 postmark was prior to or on the deadline date. As such, these exclusions should  
19 be treated as timely.

1           5.     On June 23, 2022, Kroll advised Settlement Class Counsel of the  
2 eight (8) exclusions.

3           6.     As of June 28, 2022, Kroll has received eight (8) timely postmarked  
4 requests for exclusion and no late exclusions. Each of these exclusions represent  
5 multiple parties as noted on each of the exclusion requests. A list of those entities  
6 requesting exclusion is attached hereto as **Exhibit A**.

7           7.     As of June 28, 2022, Kroll has received no objections.

8           I declare under the penalty of perjury, under the laws of the United States  
9 of America, that the foregoing is true and correct. Executed on June 28, 2022, in
